Advise appropriate management of the results of these inspections verbally and/or in writing to include hazards seen, good/bad features and overall conclusions. As appropriate monitor the action taken as a result and report to the appropriate level of management.
- Advise project personnel and site management on the determination of safe methods of working and systems to identify hazards and unsafe situations. Advise upon the production of written method statements and site SHE rules and on the arrangements to bring these to the attention of the workforce.
