- The primary responsibility of the Health, Safety & Environment (ES&H) Specialist is support services related to the construction industry: legal, safety, environmental, etc.
 - The Health, Safety & Environment (ES&H) Specialist participates in the design, implementation, and maintenance of health, safety and environmental (ES&H) programs and associated quality assurance policies and regulations.
 - Perform regular checks to verify compliance with the ES&H plan.
 - Induct and instruct new project personnel, subcontractors and third parties.
 - Responsible for updating the Project ES&H documents and ensures that copies and amendments are distributed as required.
 - Advice and support supervisory personnel on ES&H issues.
 - Investigate all ES&H incidents, including accidents, property damages, environmental incidents, near-misses, and dangerous situations.
 - Administrate and review regularly the ES&H plan and related procedures.
 - Record and review the ES&H performances achieved on the project.
 - Ensure that all project personnel is fully aware of their responsibilities with respect to ES&H and where necessary conduct "In-house training" to readdress any deficiency.
 - In consultation with the client safety representatives; establish safety induction module with compulsory attendance of all personnel, including client personnel, prior to their commencement of job/work on the project.
 - Initiate procedures for safety inspections, audits, and reports.
 - Ensuring that all items/tools/equipment of safety such as firefighting equipment, environmental equipment, and facilities are kept in best working conditions by assisting in obtaining maintenance programs and associated procedures.
 - Carrying out ES&H-MS external audits on subcontractors to verify and ensure the implementation of ES&H-MS.
 - Defining PPE requirements in accordance with company activities and including subcontractors.
 - Ensure that all safety items required in the permit to work (PTW) are adequate/available and ensure full compliance with the PTW during task being carried out.
 - Identify common risks related to the nature of core activities carried out and develop a general risk register.
 - Conducting ES&H meetings with employees to enhance safety awareness and improve ES&H performance.
 - Prepare material for safety flashes based on the outcome of the site near misses & accident reporting or from international industry resources.
 - ES&H support during heavy lifting operations. Conducting JHA for critical lifts. Coordinating with the construction team for preparing Lifting Plan for heavy and critical lift.
 - Verifying the monthly inspection reports of mobile equipment, fire extinguishers, generators & tower lights.
 - Preparation of monthly schedule of all safety activities of the project.

- Assist dredgers supervisors on board in complying with ES&H meeting program to enhance HSE awareness.
- Conduct JHA to define PPE requirements in accordance with company activities and policies.
- Produce weekly/monthly/quarterly ES&H reports & statistics.
